

Schedule of accommodation campaign for relocation to DS Pineska

October 18, 2025	Start of application submission through the ESKS system.
October 23, 2025	Last day to submit applications for the accommodation allocation process.
October 31, 2025	Deadline for submitting allocations through the ESKS system.
November 5, 2025	Final deadline to withdraw from the allocation to DS Pineska.
November 3, 2025	First day of referral validity (start of the accommodation process for persons who have been allocated a place in the campaign).
November 10, 2025	Last day of referral validity (end of the accommodation process for persons who have been allocated a place in the campaign).

Regulation of the accommodation campaign for relocation to DS Pineska

General information

1. The campaign takes place through the <https://esks.pw.edu.pl> system.
2. The deadlines for submitting applications are specified in the schedule for the accommodation campaign for relocation to DS Pineska.
3. The campaign is intended exclusively for current residents who have student status or PhD student status at the Warsaw University of Technology.
4. Losing your status as a student or PhD student at the Warsaw University of Technology after being awarded a place does not result in the loss of your place reservation.
5. *Procedures for allocating places are set out in the "Regulations for allocating places in student dormitories at the Warsaw University of Technology and accommodation fees," annexed to the Rector's Order No. 4/2025.*

Applications

6. The campaign will only consider correctly completed electronic applications, submitted within the specified deadline through an account connected to the USOS account.
7. Within the accommodation campaign, each applicant submits a standard application. For each application, it is possible to attach a document confirming medical conditions and special involvement in activities for the benefit of the university. Attachments confirming special involvement for the benefit of the university due to activities for the benefit of the academic community include:
 1. Cases of exceptional involvement in social activities that stand out from other members of the academic community and activities confirmed by the opinion of at least one of the following persons:
 - a) Rector,
 - b) Vice-Rector,
 - c) Dean,
 - d) Vice-Dean,
 - e) President of the SSPW,
 - f) Chairperson of Audit Committee,
 - g) Chairperson of Central and Programme Committees,
 - h) Chairperson of Students' Union Faculty Council,
 - i) Chairperson of Dormitory Council of Residents.
 2. Representing the academic community with success in national or international sports, confirmed by diplomas or other documents (rankings, competition results, etc.).
8. The committee has the right to request additional documents and explanations related to the content of the application. Incomplete applications will be rejected and will be reconsidered as regular applications.

9. Applications for special circumstances that are rejected will automatically be considered as regular applications within the accommodation campaign.
10. Applications must be formally correct, i.e., all mandatory fields must be filled in and accurate data provided, particularly the permanent address.

Applicant

11. Only those who have not been subject to disciplinary penalties during their stay in Warsaw University of Technology student dormitories may participate in the campaign.
12. Only people who, as of October 15, will be settled with the halls of residence, that is, will not have any outstanding payments, including payments for October 2025, may participate in the campaign.

Allocation of Places

13. By submitting an application, the applicant is only requesting a place in the DS Pineska resources and a specific room or type of room is not guaranteed.
14. Information about the preferred, e.g., room types, room compositions, or specific room numbers are only a guideline for committees assigning specific places.
15. The applicant has the option to select "If I do not receive my preferred room, please reject my application" in the application form. Selecting this option cannot be appealed.
16. The campaign has a limited number of places available. Priority will be given to those who have attached relevant attachments to their application confirming medical conditions or special commitment to the university. The remaining places will be allocated on the basis of regular applications.
17. As supportive criteria, especially in the case of applications with similar evaluations, the Commission may take into account the stage of the Applicant's studies and the order in which the application was submitted.
18. The Commission shall, as far as possible, take into account requests for shared accommodation, but in accordance with point 14 of these rules, the preferences indicated are not binding.

Referrals

19. Referrals issued as part of the campaign will be valid from November 3 to November 10, 2025.
20. When changing dormitories as part of the November accommodation campaign, a fee applies in accordance with the rates applicable at DS Pineska, as specified in the price list for accommodation in Warsaw University of Technology dormitories for the 2025/2026 academic year.
21. In order to obtain accommodation, please report to the DS Pineska administration office on a working day between 8:00 a.m. and 3:00 p.m., after checking out of your current student dormitory.
22. Failing to check in within the time specified in the referral will result in the loss of your place at DS Pineska.
