## Schedule of the accommodation campaign for newly accepted international students (full-time studies in English, summer semester 2026)

November 19, 2025	Beginning of submission of applications through the ESKS system.
January 27, 2026	Deadline for submission of applications.
January 28, 2026	Deadline for allocating places in the ESKS system.
January 30, 2026	Deadline for granting a place in the ESKS system (without room number) and creating a guarantee fee.
February 20, 2026	First day of referral validity (the beginning of the check-in process for those who have been allocated a place in the campaign.
March 9, 2026	The last day of the validity of referrals (the end of the check-in process for those who have been allocated a place in the campaign.

## Regulations of accommodation campaign for newly accepted international students (full-time studies in English, summer semester 2026)

- 1. The campaign is open to international students admitted to the first year of English-language studies starting in the summer semester of 2026 in a recruitment campaign coordinated by ISO.
- 2. Places are granted only to those who correctly complete and submit the application in the ESKS system (https://esks.pw.edu.pl) and enter the correct CID number.
- 3. Application in the ESKS system can be submitted by a person who has an "Accepted" status in the ISO recruitment system.
- 4. The condition for processing the application is to check the box in the ISO system with the confirmation of the application for a dormitory in the ESKS system.
- 5. Submitted applications must be correct in terms of formal requirements, i.e., they must include all mandatory fields filled in, contain accurate data, particularly the permanent residence address and at least one identity document number (ID card number or passport number).
- 6. The allocation of places is determined by the order of applications.
- 7. Only those who have not been punished with disciplinary penalties during their accommodation in the dormitories of Warsaw University of Technology may take part in the campaign.
- 8. Only those who, as of the date of the creation of the guarantee fee, will be settled with the dormitories, i.e. have no outstanding payments, can participate in the campaign. Persons who do not live in WUT dormitories at the time of application, but lived previously, must have a "settled" status.
- 9. The preferred dormitory selected in the application is only a hint to the accommodation committee. Selecting it does not guarantee receiving a place in it.
- 10. Those who receive a place in the WUT dormitories will have to pay a guarantee fee of PLN 500 to the account number indicated in the referral.
- 11. The guarantee fee must be credited to the account indicated in the order within a maximum of 14 days after its issuance.
- 12. Not paying the guarantee fee in the required amount and deadline is equivalent to resignation from the assigned place.
- 13. In the case of a guarantee fee of more than the fixed PLN 500, the overpayment will be credited to the first months accommodation fees.
- 14. Certificates for allocation of accommodation will be issued only after payment of the guarantee fee.
- 15. In case of resignation after payment of the guarantee fee, the fee is non-refundable.
- 16. Referrals issued as part of the campaign will be valid from February 20 to March 9, 2026. Failure to check in during this period will result in the loss of the allocated place and guarantee fee.
