

Schedule for summer period 2026

June 3, 2026	The beginning of submission of applications through the ESKS system.
June 10, 2026	Deadline for submission of applications.
June 14, 2026	Deadline for submitting applications returned for correction for formal reasons.
June 22, 2026	Deadline for granting a place in the ESKS system.
July 1, 2026	The first day of accommodation of those who have been allocated a place in the campaign.
September 21, 2026	The last day on which those accommodated in the campaign for the summer period and who do not have an allocated place for the 2026/2027 academic year must check out of the dormitory.
September 23-25, 2026	Re-accommodate those who were accommodated in the campaign for the summer period and have an assigned place for the 2026/2027 academic year to the appropriate Dormitories/rooms.

Regulations of the accommodation campaign for the summer period- 2026

General Information

1. The campaign takes place through the <https://esks.pw.edu.pl> system.
2. The summer period accommodation is available from July 1 to September 21, 2026. Those who do not have an allocated place for the 2026/2027 academic year must check out of the dormitory no later than September 21, 2026.
3. The amount of accommodation fees is determined by Decision No. 83/2026 of the Rector of the Warsaw University of Technology dated April 23, 2026.
4. Procedures for allocating places are outlined in the "Regulations for the Allocation of Accommodation in Student Halls of Residence of the Warsaw University of Technology and Accommodation Fees", annexed to the Rector's Order No. 4/2025.

Applications

5. Only electronic applications that are properly completed and submitted on time will be considered in the campaign.
6. The deadlines for submitting applications are specified in the schedule of the accommodation campaign.
7. Submitting an application means applying only for a place in the ZDS accommodation. It does not guarantee that you will receive a specific room or room type.
8. Information about preferences (e.g., dormitory, room type, room number, or roommates) is provided for reference only and is not binding on the committee.

Applicant

9. Priority for accommodation is given to those who have the status of a student or PhD student of the Warsaw University of Technology.
10. Only individuals who, have no outstanding payments to the student dormitories at the time their application is reviewed may participate in the process. Applicants who are not currently living in ZDS but have lived there before must have a "settled" status. Otherwise, their applications will be rejected for formal reasons.
11. As a condition for receiving a place in the accommodation campaign for the summer period – 2026 is the payment of all existing fees related to accommodation in the dormitory by June 15, 2026.

Allocation of Places

12. Priority will be given to those who are residents of the WUT dormitories at the time of application consideration.
13. The basic criterion for the allocation of places is the order of applications.
14. Payment terms:
 1. In the case of accommodation for a period of less than one month, payment in advance is obligatory, on the day of check-in.
 2. In the case of accommodation for at least one month applies until the 15th of every each month.
15. Persons accommodated in the dormitory as of June 30 who remain in the same room for the summer period must report to the dormitory administration by July 8 to be formally reaccommodated for the summer period.
16. Persons accommodated in the dormitory as of June 30, who are assigned another room for the holiday period, must agree with the dormitory administration on the date of reaccommodation - no later than June 30, 2026.

Referrals

17. The check-in process is based on a referral issued in the ESKS system.
18. Referrals are valid for 3 working days from the start date of accommodation indicated in the referral.

Guarantee fee

19. Persons who receive places in the ZDS for at least one month will have to pay a guarantee fee at the time of check-in or, if the quartermaster decides to do so, at the time prior to check-in indicated in the referral. The payment can be made to the account number indicated in the referral or by credit card at the administration of the dormitory where the place was received.
20. The guarantee fee for the summer period (from July 1 to September 21, 2026) is:
 1. PLN 500.00 - for WUT students and PhD students, as well as students and PhD students from other universities with which Warsaw University of Technology has concluded agreements on accommodation in WUT dormitories,
 2. PLN 1,000.00 - for other persons.
21. Certificates of allocation of places will be issued by the quartermasters only after the guarantee fee has been posted.
22. If your status (student/non-student) changes after a place has been assigned or during your stay, the guarantee fee must be adjusted to the amount applicable to your current status.

23. For residents currently living in ZDS who have already paid the guarantee fee, this fee will be credited toward the summer accommodation period after the withdrawal deadline specified in the accommodation schedule, i.e. June 26, 2026.
24. In the event of cancellation after the guarantee fee has been paid, the guarantee fee shall not be refunded.
